

Full Terms and Conditions

- **If purchased online and shipped to home:** Take a photo of the original shipping receipt with the qualifying purchase and date of purchase circled. On the eCommerce submission page upload the image of the shipping receipt. Receipts must be received by 10/31/21 at 11:59 PST.
- **If purchased online for pick-up at store:** Take a photo of the original grocery pick-up confirmation receipt with the qualifying purchase and date of purchase circled.
